

## REVIVIEYING FACE & NECK LIFT

PREPARE

Apply a serum or cream of your choice on the areas you will work on. This will allow the device to glide smoothly over your skin.

POWER ON

Hold the power button for 2 seconds to turn on the SmartSonic Pulsations.

LIFT

Roll the device along your skin in an upward and outward motion. Some common areas to go over include along your jawbone starting at the chin, over the cheekbone, and across the forehead. Roll the device along the side of your neck up to the jawbone. Make sure to cover all areas of the neck.

FINISH

Turn off the device and rinse it with water to remove any leftover cosmetics. Clean your device with our Organic Device Cleanser after every use.



## **FOCUS AREAS**

CHIN

Place the device on your chin and move it along the jawline out to the ear. Do this on both sides of the face.

CHEEKS

Glide the device from the smile lines out to the ear, covering all areas of the cheek. Do this on both sides of the face.

NOSE

Place the device next to the nose and glide it over the upper part of the cheek in the direction of the temple.

FOREHEAD

Glide the device horizontally from the center of the forehead to the temple, covering all areas of the forehead. Do this on both sides of the face.

### Your product at a glance

Your product is a rose quartz stick for the face. This can be used safely up to three times a day. Please do not use more often. For maximum safety and optim results, always follow your personalized skincare routine created by the GESKE

#### Notes on Use

Before using the device for the first time, this Safety Brochure and the Quick Start Guide must be read in their entirety. It must be fully charged before the first use. All you need is the included USB charging cable. The initial charge can take up to eight hours. The cable must dock with both magnetic contacts on the device's designated metal contact points. If the charging cable does not attach by itself, connect it to the power and wait a moment. This reactivates the magnetic effect and the contacts connect automatically. Make sure that the magnetic contacts only connect to the contact points of the device, not to other metallic surfaces.
